The DE Standard Rate applies to solar-PV systems up to 10kW capacity or as otherwise approved.
Distributor Tariff	Premises with QLD Solar Bonus Scheme approved Solar-PV systems installed prior to 30 th June 2013 may receive an additional 44 cents/kWh where eligibility is maintained with scheme rules in addition to DE Standard Rate.
