

Retail Supply Offer – Ausnet Services

The Charges provided in this **Market Contract** apply for residential electricity customers in the relevant distribution area, on the applicable network tariff and metering configuration. The Charges are exclusive of any applicable discounts and apply from the effective date below. Time-of-use Charges are also available for customers who have installed an eligible solar-PV system.

Cooling Off Period	You may cancel this agreement at any time during the 10 business day cooling off period.
Terms and Conditions	Eligibility and availability criteria apply, including that this offer is only for residential customers who are located within the relevant distribution area with the appropriate network tariff(s) and metering installation and configuration. Agreement Term	Your Agreement Term is 2 years with a Minimum Supply Period of 12 months.
Contract Expiry details	If you have not entered into a new agreement with us, then we will continue to sell electricity to you under this agreement on the same Terms and Conditions at that time.
Charges and Discounts May Vary	We may vary the Charges (including the amount and structure of any Charge), discounts, Feed-in Rates and Terms & Conditions from time to time consistent with the applicable Terms & Conditions.
Method of Payment	You can choose to pay invoices by any of our payment options.

Solar Feed in Tariff / Rate

Feed-in Tariff: Distributor Funded	PFIT Scheme is closed to new solar-PV installations. Existing Solar-PV installations receiving PFIT will continue to do so as per scheme rules and where they maintain eligibility. DE Standard Rate will also apply to increase feed in rate to 72 cents/kWh for eligible PFIT participants.
DE Standard Rate	12 cents/kWh for all export electricity where net metered, subject to change as per the Feed-in Terms and Conditions. The DE Standard Rate applies to solar-PV systems up to 10 kW capacity or as otherwise approved.

Fees

Credit card payment processing fee	0.60% (including GST), may be applicable if you choose to pay by Mastercard or Visa credit cards.
Dishonoured payment fee (cheque)	\$20 (including GST), may be applicable if payment is not honoured by your bank.
Dishonoured payment fee (direct debit)	\$10 (including GST), may be applicable if payment is not honoured by your bank.
Establishment fee	\$22 (including GST), payable upon transfer to us from another retailer.
Termination fee	\$22 (including GST), applicable if the contract is terminated in the first 12 months.

Discount - Direct debit	3% discount on daily supply charge and usage rates where full payment is made by automated direct debit.
