

Retail Supply Offer – Endeavour

The Charges provided in this **Market Contract** are our single-rate, two-rate (with controlled load) & time-of-use offers for residential electricity customers in the relevant distribution area, on the applicable network tariff and metering configuration. This offer is also available for customers who have installed an eligible solar-PV system.

kWh: a 'kWh' stands for kilowatt hour and is the unit of measurement for your electricity usage.
