DE Standard Rate	Customers with eligible Solar-PV systems will receive 12 cents/kWh for all export electricity (net metered only), subject to change as per the relevant Terms & Conditions with at least the minimum Government Regulated rate being payable as applicable. The DE Standard Rate applies to solar-PV systems up to 10kW capacity or as otherwise approved.
Feed in Tariff: Distributor Funded	Premises with QLD Solar Bonus Scheme approved Solar-PV systems installed prior to 30 th June 2013 may receive 44 cents/kWh where eligibility is maintained with scheme rules. The DE Standard Rate will also apply to increase feed in rate to 56 cents/kWh for eligible Qld Solar Bonus Scheme customers.
