Solar Feed in Rate / Tariff

DE Standard Rate	Customers with eligible Solar-PV systems will receive 12 cents/kWh for all export electricity (net metered only), subject to change as per the relevant Terms & Conditions with at least the minimum Government Regulated rate being payable as applicable. The DE Standard Rate applies to solar-PV systems up to 10kW capacity or as otherwise approved.
Distributor Tariff	The SA Solar Feed-in Scheme is closed to new PV installations. However customers already receiving an SA Solar Feed-in Scheme Tariff will continue to do so as per their eligibility, in addition to DE Standard Rate being either: (i) 56 cents for all export kWh; or (ii) 56 cents for all export kWh up to the first 45 kWh per day.
