Solar Feed in Rate / Tariff

DE Standard Rate

Customers with eligible Solar-PV systems will receive 12 cents/kWh for all export electricity (net metered only), subject to change as per the relevant Terms & Conditions. The DE Standard Rate applies to solar-PV systems up to 10kW capacity or as otherwise approved in writing by us.

Fees

Credit card payment processing fee

0.60% (including GST), may be applicable if you choose to pay by Mastercard or Visa credit cards

Dishonoured payment fee (cheque)

\$20 (including GST), may be applicable if payment is not honoured by your bank.

Dishonoured payment fee (direct debit)

\$10 (including GST), may be applicable if payment is not honoured by your bank.

Late payment fee

\$15 (including GST), may be applicable if payment is not received before the due date.

Establishment fee

\$22 (including GST), payable upon transfer to us from another retailer.
